Dear Customers and Suppliers,

While we all are aware of the panic and fear that has been caused by the rapid spreading of COVID-19 globally, and the new regulations set out for our country by government, we assure you that we have instituted additional procedures and controls, maintaining very strict hygiene policy at all times.

The following precautionary procedures have been instituted as well over and above the usual daily procedures:

- Electronic thermometer to scan all employees and visitors before entering premises
- Entry refused to anyone that has a fever and to advise them to seek medical advice
- A register kept of all visitors entering the reception area other than staff
- All visitors required to complete a health questionnaire which will serve as a register for traceability
- Everyone to keep the prescribed distance when communicating
- Company representatives work from the office and do not have face to face meetings

Deliveries:

- All delivery vehicles are equipped with sanitizing spray bottles and masks.
- Staff members have been advised to spray their hands before and after each delivery point.
- To wash their hands, also the back of their hands and wrists thoroughly for 20 seconds with soap and water when available.
- Vehicles are thoroughly washed daily at return to base or before they leave.

General:

- All workstations to be sanitized regularly during the day
- Check all staff member temperatures upon arrival before entering premises
- Regularly remind staff to wash hands frequently
- Quarantine employees who appear to have symptoms of respiratory illness i.e. cough, shortness of breath, fever until they can return home and receive medical attention
- Any staff member who may develop a respiratory illness to be instructed to immediately consult a doctor and provide a medical clearance certificate before returning to work
- All frequently touched surfaces in the workplace such as workstations, doorknobs, phones etc. to be sanitized regularly
- Update all staff on the latest information available on the COVID-19
- Staff encouraged to bring own food for meals and rather to avoid visiting food outlets in order to minimize re-entering the premises numerous times.
- Staff in the production area to adhere to strict hygiene protocol always.
